### **Payment Terms**

Payment of account is required strictly 30 days and due by the end of the month following delivery.

### **Return of Goods**

All returns must be authorised by Mediamix Australia Pty Ltd and invoice numbers and date quoted. All goods are to be returned in their original packaging.

### **Overdue Account**

Mediamix Australia Pty Ltd has the right to charge an overdue interest if an account is not paid by the due date. This amount is subject to change, depending on current interest rates and will be calculated daily.

### **Ownership of Goods**

The customer agrees that the terms and conditions shall be deemed to be incorporated in every contract for the supply of goods between Mediamix Australia Pty Ltd and the customer.

The goods are the responsibility of the customer/recipient upon delivery but remain the property of Mediamix Australia Pty Ltd until at such time as full payment is received for all monies owing whatsoever by the customer to Mediamix Australia Pty Ltd within the trading terms stipulated above.

Full legal ownership of the goods is retained by Mediamix Australia Pty Ltd:

1. If an official manager or receiver or receiver and manager of the customer is appointed (in the case of a company);
2. If winding up proceedings are commenced against the customer (in case of a company);
3. If the customer commits an act of bankruptcy or attempts to bring his/her estate within the operation of any bankruptcy legislation for the time being in force (in case of national person/s).

Jurisdiction Clause – in the event of litigation of default of payment, we agree that the action for recovery can be commenced out of the Court of Competent Jurisdiction in Australia. Mediamix Australia Pty Ltd has the right to enter the premises of the customer and retake the goods and resell the goods.
